Board News Breakdown

These highlights are a summary of actions taken and topics discussed by the COAERS Board.

89th Texas Legislative Session

The COAERS Board approved its statement of priorities for the 89th Legislative Session, which states: COAERS will work to ensure that proposed legislation that would, in any way, erode or impair the Board's fiduciary authority or otherwise negatively affect the System and its members, is amended or changed to meet its fiduciary duty.

Investment Update

In January, COAERS issued a Request for Proposal (RFP) seeking qualified firms for the services of private markets investment consulting to provide independent, unbiased, proactive research, information, and advice to the Board and Staff in regard to the COAERS fund. This will allow the Board to be best equipped to make rigorous and thorough assessments of its investment options in seeking robust long-term returns at acceptable levels of risk.

The Board also adopted a revised Investment Policy Statement, which establishes the objectives and policies of the System's investment program, and articulates the policies, guidelines and procedures that are employed in the day-to-day management of System investments by Staff.

Interest Posting

At the December 2024 meeting of the COAERS Board, Trustees set the interest rate paid on member deposits at 4.19% as recommended by the COAERS actuary. Interest was credited as of December 31, 2024, on deposits in member accounts as of January 1, 2024.

Benefits 101: Naming a Beneficiary

Keeping your beneficiary information current is a small but crucial step in protecting your loved ones and ensuring your retirement benefits are distributed according to your wishes.

Life changes, such as marriage, divorce, the birth of a child,

or even a change in relationships, can impact your beneficiary choices. An outdated designation could lead to unnecessary complications or delays for those you intend to provide for.



Updating your beneficiary is simple and only takes a few minutes. If you're unsure of your current designation or need to make changes, login to MemberDirect to review your beneficiaries and complete your Beneficiary Designation Form. You can also visit www.coaers.org/forms to access the form.

Tax Prep Reminder: Form 1099-R

Retirees can access and download your Form 1099-R through MemberDirect.

What's on Your 1099-R?


Form 1099-R reports the pension earnings for the 2024 tax year and provides information you'll need to complete your tax return. Retirees who received a payment from COAERS during 2024 will receive a Form 1099-R.

Changes to Deductions and Withholdings

Any insurance enrollment choices and plan changes you have elected may change your net benefit. Be sure to review your deductions for accuracy. You can log onto Member Direct to review any changes that may have impacted you. If you need help regarding your tax withholdings, please seek guidance from a qualified tax advisor.
